## Call for Expressions of Interest for Exciting Contract and Employment Opportunities on a CN Project!

CN is currently seeking Expressions of Interest from Algonquin contractors, suppliers and members for contracting and employment opportunities for upcoming work at the Mile 109 site in Algonquin Park. Information received will be used to solicit bids for the upcoming remedial activities and passed on to subcontractors for partnering opportunities for the project.

The tendering, award process and schedule of the work (likely starting in June 2017) is still being finalized, however, there will be opportunities to bid for contractors and employment for individuals with capabilities in the following:

### 1. Sand and Gravel Supplier

- Description: Sand and Gravel will be required for road preparation, maintenance work and site grading.
- Material Requirements: Material will need to be free from weeds and invasive species. The source will be subject to approval from CN and Ontario Parks.

### 2. Trucking of Sand and Gravel

- Description: Trucking contracts may be awarded for transportation of sand and gravel e.
- Equipment Requirements: Larger trucks are preferred but all submissions will be considered.
- Licensing Requirements: Appropriate driver license class for equipment (G,AZ, DZ);
- Insurance Requirements:
  - CGL \$2,000,000
  - Automobile Liability \$2,000,000
  - Environmental Impairment \$2,000,000
  - WSIB – Statutory Requirements

### 3. Road Maintenance/ Upgrades

- Description: Road maintenance work will be required on Beechnut Lake Road and on the logging road to prepare access to the site as well as to maintain the road during the remediation program. The upgrade work may be completed in the Fall of 2016 with the maintenance being conducted from June to October 2017 during the full scale remediation.
- Equipment Requirements: Equipment to supply granular (aggregates) and grade the roads.
- Licensing Requirements: Appropriate driver license class for equipment (G,AZ, DZ)

### 3. Road Maintenance/ Upgrades (cont'd)

- Insurance Requirements:
  - CGL \$2,000,000
  - Automobile Liability \$2,000,000
  - Environmental Impairment \$2,000,000
  - WSIB – Statutory Requirements

### 4. Trucking of Contaminated Soil Offsite

- Description: Trucking contracts may be awarded for transportation of contaminated soil to the receiving landfill (east of Ottawa). One trip per day due to travel time.
- Equipment Requirements: Up to 18 Trucks with Trailers (min 22 m<sup>3</sup> capacity).
- Licensing Requirements: Appropriate driver license class for equipment (G,AZ, DZ); Licensed waste hauler in the province of Ontario
- Insurance Requirements:
  - CGL \$5,000,000
  - Automobile Liability \$5,000,000
  - Environmental Impairment \$5,000,000
  - WSIB – Statutory Requirements

### 5. General Construction Equipment

- Description: From time to time there may be a need for flatbed trucks, floats, lifts, etc. to support the remediation project.
- Equipment Requirements: To be determined.
- Licensing Requirements: Appropriate driver license class for equipment (G,AZ, DZ)
- Insurance Requirements:
  - CGL \$2,000,000
  - Automobile Liability \$2,000,000
  - Environmental Impairment \$2,000,000
  - WSIB – Statutory Requirements

### 6. Boat Supplier

- Description: Rental of boats may be required for environmental monitoring and installation of environmental control measures.
- Material Requirements: Small stable boats capable of operating within the shallow wetland, Indian River and Reserve Lake to collect water samples and install silt curtains. The supplier will be expected to follow project protocols for the control of potentially invasive species.
- Registration Requirements: Non-pleasure vessels powered by an engine of 10 horsepower or more must be registered with Transport Canada's Small Vessel Register (Commercial) or the Canadian Register of Vessels.

### 7. Construction Site Services

- Description: Rental of construction trailers, washroom facilities etc. for the remediation project (June to September 2017).
- Material Requirements: Site trailers, washrooms, etc.

#### **8. Environmental Monitor (1 – Full Time)**

- Description: Assist with monitoring of surface water and conducting biological surveys during the remediation project (June to September 2017).
- Education: Enrolment in a post-secondary environmental science/engineering, biological science or environmental studies program an asset.
- Training/Certifications: Provide information on relevant training/ certifications

#### **9. Construction Labourers (Up to 2 – Part Time or Full Time)**

- Description: Assist with day to day work onsite related to maintaining the site and implementing the site's Health and Safety Plan and Environmental Control Plan (June to September 2017).
- Training: Construction site experience an asset.

#### **10. Site Access Coordinator (1 – Full Time)**

- Description: Assist with coordinating site access for haul trucks and deliveries, collecting and collating weigh tickets, assisting with site security and implementing the site Health and Safety Plan (June to September 2017).
- Training: Construction site experience an asset.

#### **11. Equipment Operators (As Needed)**

- Description: There may be a need for equipment operators for backhoes, trucks, dozers etc. through the subcontractors awarded components of the remediation contract.
- Training: Proper class of driver's license for equipment. Provide information on relevant training/ certifications.
