The Corporation of the County of Renfrew is inviting bids for the sale of timber on Renfrew County Forest. Timber will be sold on a per unit basis (by the cubic metre) for five (5) tracts on the Renfrew County Forest.

1. **Sale DPF 01-22: Lorwall Lake Tract.** Brudenell Township. Red pine plantations, 3rd thinning. 39 hectares. Good access.
2. **Sale DPF 02-22: Brudenell Tract.** Brudenell Township. Cedar and mixedwood. 16 hectares. Good access. Frozen conditions only.
3. **Sale DPF 03-22: Beachburg Tract.** Westmeath Township. White pine shelterwood. 43 hectares. Good access. Short timing restriction for recreational event.
4. **Sale DPF 04-22: Round Lake Tract.** Hagarty Township. Red pine and small spruce plantations, 2nd thinning. 18 hectares. Fair access, permission through private required. Timing restriction.
5. **Sale DPF 05-22: Ruby Tract.** South Algona Township. Hardwood selection, shelterwood and mixedwood clearcut. 64 hectares. Good access. Timing restriction. Two-year contract.

A **site viewing** through private land to evaluate Round Lake Tract will occur with County of Renfrew staff. Please indicate in your request for the tender package whether you wish to attend this viewing and details will be provided.

All bidders must possess appropriate certification as per the contract specifications.


